Bl. Frederic Ozanam, our founder, once said, "Our main purpose is not merely to help the poor - this is but a means to an end. Our true aim is to preserve in ourselves the Catholic Faith in all its purity and to communicate it to others through the channels of charity."

What better opportunity to demonstrate our Vincentians' dedication to this aim than coming together for a special Liturgy at St. Agnes Cathedral! On November 7th at 3:30pm, almost 300 members of the Society gathered for a Mass of Thanksgiving, celebrating the years of service they have offered to the Diocese of Rockville Centre. Bishop John O. Barres was the principal celebrant

with Msgr. Jerry Ringenback, our Diocesan Council Spiritual Advisor concelebrating. Bishop Barres offered the following reflection during his homily, "May we as Vincentians, as sons and daughters of St. Vincent de Paul, of St. Louise de Marillac, as sons and daughters of Bl. Frederic Ozanam, give ourselves entirely to God in our neighbor."

He consistently shared a message of imitating the Saints in our lives. The Liturgy was a unique opportunity to bear witness to the three essential elements of the Society of St. Vincent de Paul: spirituality, friendship and service. The Vincentians in attendance represented our shared ministry beautifully!





A Dismas House Story

Kenneth is soft-spoken and reflective, but with a fierce drive to do what he needs to do to continue his journey to a better life. He says continue because he realized, while still in prison, that the journey needed to start then and there. Kenneth said, "I had to change my mindset in there to be successful out here." Waiting until he walked out the doors would be a mistake. Kenneth's family wanted him to stay with them. While that support system is important, Kenneth believed it was important to find his own way.

At Dismas House, Kenneth found the best of both worlds, he would have the independence to learn to navigate the "outside world" and prepare himself to be independent, but in a more structured environment than a half-way house. He would get help finding a job, getting a new ID, his driver's license, continue with any support programs he needed, have responsibilities around the house that would make him an accountable member of the Dismas House family!

He also would be surrounded at Dismas House by people that were familiar with the obstacles he would face. It is still an intimidating transition. Kenneth describes the first few sleepless nights

in his new bed. He was scared about how he was going to get from place to place, living in a suburban setting. He knew nothing of cell phones with GPS! He described the frustration of realizing the ID issued from the State Department of Corrections was not helpful to advance his goals. Kenneth speaks with great respect for the people that went out of their way to help prepare him for his parole hearing and ultimate release. The Parole Preparation Project uses trained volunteers to help navigate the parole release process. For an inmate, accepting that these people are there to help and want the best for them is difficult. At first, it is hard to trust. "For me, the more time I spent with them, the more I was able to open up, let them help me," he remembered. This trust building is also foundational to the success of the Dismas House program. Their kindness has motivated Kenneth to give back, he plans on becoming a volunteer counselor in the program.

Kenneth is happy he chose Dismas House. He needs to be a little selfish right now, focus on himself, finding his way and working hard as he continues his journey. He also reflects, "I feel a responsibility to the people who believe in me and are helping me, from the volunteers in the Parole Preparation Project, to the staff at Dismas House and my family."



The excitement at Bethpage Community Park for the 13th Annual Friends of the Poor Walk was unmistakable as hundreds of Vincentians and their friends and family were able to join in person to highlight our mission. After COVID forced an in-person hiatus last year, the park was full of Vincentian Charism of fellowship as we walked to raise awareness and funds to fight poverty on Long Island.

We were thrilled to have the Honorable Bishop Barres in attendance as well as local elected officials Rose Walker, Nassau County Legislator and Assemblyman John Mikulin. This year's Walk raised \$200,000 through individual donations and sponsorships. Presenting sponsors were Steel Equities, Florence Building Supplies and De Marco & Nesi, LLC. 












Lending support to a neighbor

In the midst of the pandemic, one of our Vincentians, Cindy, encountered an adult woman, who is Autistic.

The woman lived at home with her father, who was failing in health. She was starting to feel anxious about her future should something happen to her father. Due to her disability, the isolation of the pandemic was starting to take its toll. Two of our Vincentians, Dan and Cindy decided to do a home visit to determine if we could be of assistance, not knowing what, if anything, we could offer.

Mostly, they just listened to her describe her anxieties. The neighbor was not always open to suggestions of services, but they left her the information and agreed to visit at a later date.

After one of the visits, Dan was listening to a sports radio station when he heard a commercial about the Winter's Center for Autism. Normally, he would never pay attention to the radio ads, but after a home visit with this neighbor, it resonated with him. Dan contacted the Center and spoke with a case worker. She described the services they provide, and offered to visit with the neighbor if the neighbor was agreeable to that.

Subsequently, the neighbor's father passed. We learned that her father had friends and colleagues who helped her with final arrangements and settling of the estate. The neighbor was very comfortable with her support system and told us she would contact us if she needed anything.

This may not sound like a very good success story. Rather, it is a story about the spirit of Vincentians lending support to a neighbor in need without supplying money or solving their problems. It was simply being kind and taking the time to listen to someone's troubles. But, it also unlocked a valuable resource should we encounter something like this again. The Winter's Center for Autism could be a valuable resource for Conferences working with a neighbor on the Autism Spectrum.



If you are 70½ years old or older, you can take advantage of a simple way to benefit the Society of St. Vincent de Paul Long Island and receive tax benefits in return. You can give any amount up to \$100,000 per year from your IRA directly to a qualified charity without paying income tax. This popular gift option is commonly called the IRA charitable rollover, or a Qualified Charitable Distribution (QCD).

This is a great way to support the mission of the Society today! Your gift will be put to use today, allowing you to see the difference your donation is making, and you will pay no income taxes on the gift, up to \$100,000. The transfer generates neither taxable income nor a tax deduction, so you benefit even if you do not itemize your deductions. If you reached the age of 70½ on or before December 31, 2019, you can use your gift to satisfy all or part of your required minimum distribution

for the year. If you turned 70½ on or after January 1, 2020, you can use your gift to satisfy all or part of your required minimum distribution starting at the age of 72. (Note: The RMD requirement has been waived for 2020, per the CARES Act signed into law on March 27, 2020.)

Since the gift does not count as income, it can reduce your annual income level. This, in turn, may help lower your Medicare premiums and decrease the amount of Social Security subject to tax.

Don't forget the transfer must be made by December 31st to count against the year's RMD requirement.

Please seek the guidance of your accountant or financial planner for the best way to achieve your qoals.
